#### The Italian Brotherhoods

Geographical distribution

In Italy there are approximately 7,000 Confraternities, with over 2,000,000 members including Brothers and Sisters, distributed as follows in the Territories:

About 50% in the SOUTH

About 25% in the CENTRE

About 25% in the NORTH

## The Italian Brotherhoods Organization

In many Italian Dioceses, for a homogeneous and more functional internal organization, the Confraternities are aggregated in

#### Centers / Federations / Brotherhood Unions

which are internal offices of the Curia structured as follows:

- Lay manager for administrative aspects
- Episcopal Delegate for spiritual aspects
- Board of directors

The Confederation of the Confraternities of the Dioceses of Italy always has its birth

### The Italian Confraternities and the Bishop

The Bishop (cann. 314 et seq.) accompanies the Confraternities in the most significant moments, directly and/or through the appointment of his own Delegate for the Confraternities:

erects / extinguishes the Brotherhood

approves the Statutes (ius proprio of the C.J.C./CCEO Body)

authorizes processions

authorizes elections for the renewal of the Bodies

supervises the administration of the Confraternities subject to him (annual sending of reports and inventories to the Curia or replacement of the administrator in case of negligence, can. 1276 and 1279).

Sollemnis Conventio inter apostolicam sedem et poloniae rem publicam

Concordat between the Holy See and the Republic of Poland

stipulated in Warsaw on 28 July 1993

#### Sollemnis Conventio inter apostolicam sedem et poloniae rem publicam

#### Article 4

- 2. The Republic of Poland also recognizes the juridical personality of all ecclesiastical, territorial and personal institutions, which have such personality in conformity with the norms of canon law. The ecclesiastical authority duly notifies the competent bodies of the State.
- 3. At the request of the ecclesiastical authority, other ecclesiastical bodies may obtain legal personality under Polish law

## The Confederation of Brotherhoods of the Dioceses of Italy

In 2000, the Italian Episcopal Conference (C.E.I.) erected

#### The Confederation of Brotherhoods of the Dioceses of Italy

public canonical juridical person (cann. 298, 301 and 312-320 C.J.C.)

established among the Confraternities canonically recognized in the Dioceses of Italypersona giuridica canonica pubblica (cann. 298, 301 e 312-320 C.J.C.)

The Confederation counts well over 3,000 Brotherhoods among its members and, for about 20 years now, it has represented a point of reference for the Sodalities, also with regard to important projects launched.

### Institutional activities of the Confederation

The Confederation of the Confraternities of the Dioceses of Italy, by statutory mandate, deals with

- coordinate and accompany the registered Brotherhoods in carrying out common activities (art. 2 Statute).
- > organize Catechesis / Training
- organize, in agreement with the host Dioceses, of both Regional Paths
   and National Paths on an annual or biennial basis
- organize Information (own means of communication TRADERE periodical, website with publications and subsidies, Facebook page).
- support in the conservation of cultural and archival assets of which many Confraternities have been custodians for centuries

### Institutional activities of the Confederation

The Confederation of the Confraternities of the Dioceses of Italy also supports the Confraternities through its own internal commissions:

- > Young Brothers of Italy Commission to support young brothers
- Legal Commission, on specific topics of interest to our associations such as Statutes and Regulations, Privacy, Cemetery niches, Third sector, etc..

# Institutional activities of the Confederation

The purpose of the Confederation is not to overlap with the Dioceses or Bishops,

# Activities of the Confederation 2023 - 2024

#### "ICONA Pilgrimage"
